Scams Submitted by Our Readers

Subscription Renewal Scam

A reader reported that there was a message on her answering machine regarding an automatic renewal of a subscription in the amount of \$499.00. If the company did not hear from the reader, the amount would be billed to her checking account or credit card based on how she paid previously. The caller directed the reader to call a number and press 1 within the next 24 hours.

The message does not mention the name of the company or what was purchased by subscription. It is intended to get the recipient of the call to phone back and press one. The reader did not respond to the message so we are not sure what would have happened if she had called. She knew that if she had a subscription to anything, she would have paid by check. She watched her bank account and no withdrawal was made so she knew it was a scam. If a person had paid with a credit card, watching the card statement would have revealed if funds had been removed. Also you could contact the card company and ask them not to pay that bill.

Scam Involving Best Buy

Another reader received an email message stating that a charge had been made to her Visa card in the amount of \$455 at Best Buy. If she had made this purchase, press a button that said "yes" and if she did not make the purchase, press the button that said "no".

The reader had not made any recent purchases from Best Buy. She did not respond to the message. If she had replied, she would have been probably gotten a request to provide her name, mailing address and credit card number. The message would say this necessary information to ensure that they had contacted the correct person. In reality what they do would be to use the personal information for their own purposes which might include buying things in the name of the person who replied or to selling their information to other scammers. If you had a question about the message, call the credit card company directly. Do not reply to the message.

Publishers Clearing House Scam

A reader received an email message saying he had won \$850,000 in the Publishers Clearing House email drawing. The notice states that this person's address had been submitted by him or another person and it gives the ticket number drawn with his email address on it. In order to collect, he needs to provide his name, mailing address, phone number, date of birth and gender. It says once you reply with the above information, he will receive further contact. The messages gives the name of the person who is supposed to be the "lottery agent" and the location of Atlanta, Georgia, United States.

Probably at the time of further contact, they will need your bank account number saying they are going to wire the money to your account rather than putting such a large check in the mail. If you look at the email address, you will find that it came from Jakarta, Indonesia. Publishers Clearing House will not be contacting you from Indonesia. This is another effort to get personal information that can be used for more scams.

Scam Involving FedEx

An email message was sent to a reader saying that FedEx had been unable to deliver a package to him because the address was wrong. In order to get the package, he had to click on a link and enter the correct delivery address.

The logo in the message looked authentic and the type of identifying number given for the package was like one that FedEx would use. Examining the email address of the sender shows that it originated in India. The reader was certain he had not ordered anything from India. That was a clue that it was a scam.

Don't click on links in any email messages from someone you do not know or a business where you did not initiate the contact. Scammers most often use the names of well-known companies in order to attempt to trick people into giving over their personal information or even verifying that their phone or email address is correct. A legitimate company will not do this.

Another Scam Involving IRS

The Maine Office of the Attorney General is warning Maine people that scammers are making phone calls saying they represent the IRS. The caller says it has been discovered that you have invested in binary options and consequently are an accessory to an international drug smuggling ring. Also you have an offshore bank account. The caller said he needed to notify the local District Attorney and the Maine Attorney General. Next it sounds like a police scanner in the background and the scammer claims to be in communication with law enforcement officials on a two-way radio. The caller will state that you could get out of this predicament either by having agents come to your house to arrest you or you by paying a \$1,000 fine.

This type of scam is set up to threaten you enough to pay the money. Remember that the IRS makes contact with people through letters. They do not call telling you that you are about to be arrested and they do not demand that you make immediate payment.

Scammers Target Families of Deceased

In April, the Federal Emergency Management Agency announced that they would reimburse any American family for funeral expenses paid for victims of COVID-19 up to \$9,000. Survivors can contact the agency at *1-844-648-6333* for information on how to apply.

Scammers have been contacting people by phone and internet telling them the funds are available for funeral expenses to survivors. These scammers will ask for a death certificate and evidence of the amount you paid as FEMA would. Also, they may say they need your name, address, Social Security number and bank account number or the Social Security number of the deceased. The scammer may ask you to pay for the assistance. Don't give information or money to someone who calls out of the blue. FEMA will not do that. If you have doubts about a call claiming to be from FEMA, hang up and phone FEMA at the number above.

Auto Warranty Scam

Around the country, people are reporting getting a phone message from "Susie" with the "Vehicle Services Department" calling about your vehicle warranty. The recorded message may be something like they have sent you several notices in the mail and are now calling because you have not extended your vehicle warranty even though the manufacturer's warranty has expired. The message goes on to say that they are going to have to close your file if you do not respond. The message then says that if your are interested in extending your warranty you should press a number or a different number if you want your name to be removed from the mailing and call list.

The persons behind these calls are not likely to be your car dealer or manufacturer. They are not selling service warranties. They are trying to sell a service contract that often costs hundreds of dollars. If you buy it, you may find that if you submit a bill, the contract does not cover any of the problems you have with your vehicle. If you get a call like this, just hang up. These calls are going to everyone whether or not they have a warranty on their vehicle.

Coronavirus Survey Scam

Nationwide, people are getting emails and texts asking them to fill out a survey about the brand of COVID-19 vaccine they received. The message will state that you will receive a free reward for responding. After a person answers the questions to the survey, they are asked to provide the numbers for a credit card or checking account to pay the shipping fees on the "free" reward. Paying the shipping for what is said to be free is a clue there is a problem.

- Do not respond to one of these surveys.
- Do not give any personal information.
- Do not call the phone number listed in one of these messages.
- Do not click on any attachments. Scammers sometimes install damaging programs on you computer this way.

More Scams

Romance Scams

The pandemic left single people isolated and lonely with not much to do. Many turned to online dating sites and apps. The Federal Trade Commission reported that there were four times as many complaints about being scammed through a romance connection in 2020 over 2019. Those hardest hit were those 70 and older. The average loss was \$9,475.

The typical scam started online with light conversation. The person asks to move off the dating site to a more private setting like email, texting, or phoning. Time goes by and the scammer eventually convinces the target that their relationship is real and that they will be together one day. Next comes a request for money. It might begin with something like we might not be able to talk any longer because my phone bill has gotten high and the service is about to be cut off. Could you send me \$300? Next it might be that he/she wants to come to meet you but cannot pay for the ticket. The person may say they come from a distant state and it is expensive to get to you by air. Once air fare is received, there will be another issue requiring more money so they could not buy to ticket. If you stop sending money, the new friend will disappear.

No matter what the story, if someone you never met in person asks you for money, it is very likely a scam. If the person asks you to send gift cards or to wire money, it is a scam. Be very careful when it comes to meeting a person online. A stranger can easily take your money and break your heart.

Free Genetic Testing Scam

Around the country, people report getting calls from someone claiming to represent Medicare or an official-sounding organization. The caller says they are providing **free** genetic testing kits. All you need to do is to agree to receive a kit in the mail that includes a swab, a vial and instructions. You simply swab the inside of your cheek, put the swab in the vial and return the vial. This test will tell you if you carry genes that make you more likely to develop heart disease, cancer or other common conditions. The caller insists that the test will be totally covered by Medicare. Sometimes they even offer a gift card or other gift for taking part.

This may sound useful information but there is a catch. Before they can mail the kit, they need to have your Medicare identification number and personal health information going back to you grandparents.

This is a variation on a scam that was going on a few years ago where scammers were offering the same testing kits at health fairs or going door-to-door in senior housing facilities. It is now being conducted over the phone so it is harder to get caught.

Genetic testing is certainly a legitimate service. However, the scammers here are committing fraud by billing Medicare for unnecessary tests. For the consumer, it can lead to medical identity theft and sometimes a bill for thousands of dollars for a test results never received.

This is another example where someone like a doctor needs to be involved in the scam to be eligible to bill Medicare. That person hires others to make calls and collects Medicare IDs to submit for payment. The consumer may or may not receive a kit.

The caller says the service is free. If free, then you should not have to give your Medicare number. The scammer is out to bill Medicare in your name. These scams raise Medicare premiums for all of us.

Things To Know



Emergency Broadband Benefit

This is a service of the Federal Communications Commission (FCC) to help people who are struggling to afford internet service during the COVID-19 pandemic. The concept is to help people to connect to available jobs, healthcare services, virtual classrooms, and more. The program will provide up to \$50 per month toward broadband service and a one-time discount of up to \$100 toward the purchase of a computer or tablet from participating providers. There is a limit of one monthly service discount and one device discount per household. There funds will continue until the pandemic is declared to be over or until the funds run out.

To be eligible, a household must meet one of the following criteria:

- Have income below 135% of the poverty level or participate in SNAP, Medicaid, Lifeline or other assistance programs;
- Be approved to receive benefits under the free/reduced-price school lunch program;
- Received a Pell Grant during the current award year; or
- Experienced a substantial loss of income due to job loss or furlough since Feb. 29, 2020.

An eligible household must both apply for the program and contact a participating provider to select a service plan. There are three ways to apply:

- Contact a participating broadband provider to learn about their application program. If you cannot do that, then use one of the other options.
- 2. Go to www.getemergencybroadband.org. Here you can apply online and find a participating provider near you. After you do this, you will have to contact a participating provider.
- Call 1-833-511-6311 for a mail-in application. You will need to return it with copies of the required documentation to show proof of eligibility.

Better Business Bureau

The Better Business Bureau was established as a non-profit organization in 1912 for the purpose of helping consumers find businesses and charities they can trust. They also mediate issues between customers and businesses. Below is an example.

A reader contacted a national insurance company asking for a quote on auto and homeowner's insurance as he wanted to compare the price he was currently paying with that of other companies. Within a few days he received policies for both plus a bill. He called saying that he did not agree to **buy** the insurance. The person he got on the line said she could not help with that and she would transfer him to another person who could deal with it. After waiting on the line for several minutes, the line went dead. With the next call, the same thing happened. So he returned the bill with a note explaining that he had only wanted a quote. There was no reply to that. When the next bill came, he called again and got the same response that he had gotten with the previous calls. He wrote a letter explaining what had happened. He got no reply. A note was attached to the third bill saying they were going to have to cut off his insurance for non-payment but he owed for the previous months. He called again and got the same type of response from the customer service person.

Next he contacted the Better Business Bureau. He explained what happened and provided a copy of the note and letter plus the dates of his phone calls to the insurance company. Within a few days he got a call from the insurance company saying they had received his complaint through the Better Business Bureau. The spokesperson said she could not see how any of this could have happened but she had canceled the policies and he owed nothing for the coverage they gave him.

He had struggled with this issue himself for nearly three months and it was corrected in a few days once the Better Business Bureau got involved. If you have a problem with a company that you cannot resolve, you might try getting help from this organization.
